**I hereby:**

- 1) acknowledge that I and my child have read and understood the Competition Regulations available at the Organizer’s website: <https://www.almaty-marathon.kz/> (hereinafter – “Website”), and we absolutely agree to follow them;
- 2) acknowledge that my child has had a medical check by a doctor and has no counter-indications to participate in the Competition and undertake that I don’t allow my child to participate in the Competition, if my child’s health deteriorates by/on the Competition date;
- 3) am aware of and understand the complexity of the Competition and acknowledge that my child has sufficient technical knowledge and skills in running the declared distance of the Competition and that he/she is physically and mentally well-prepared for participation in the Competition;
- 4) am aware of the fact that my child’s participation in the Competition may result in the adverse health consequences, and I shall be fully responsible for my child’s safety and health;
- 5) acknowledge, agree and declare that the Organizer shall not be liable for my child’s death or injury and/or other damage to the child’s health as a Participant of the Competition, loss or damage to our personal belongings, as well as any physical harm to my child as a Participant of the Competition, occurred during the Competition, and I shall voluntarily and knowingly refuse from any material and other claims and demands towards the Organizer (its employees) and sponsors of the Competition. This refusal from the claims shall apply to my potential successors and caregivers and shall be valid before, during and after the Competition;
- 6) I confirm that during the Competition, neither I nor my child will, under any circumstances, intentionally create situations that may cause harm of any kind to other participants, the Organizer, the sponsors of the Competition, third parties, or their property. I also undertake to fully compensate for any damage caused;
- 7) acknowledge that for the compliance by the Organizer with the Law of the Republic of Kazakhstan “On Personal

Data and Their Protection", for my child's registration for the participation in the Competition:

- I agree to provide the documents supporting the information in this Acknowledgement (my and my child) upon the Organizing Committee's request, and give my consent to collect, process, use and store personal data;
  - I grant the Organizer the right to use my name and my child's name, as well as to publish, reproduce, and distribute images, audio, video, and photographic materials featuring me and my child, obtained during the Competition, by any means and in any manner, without limitation in time or territory.
- 8) pursuant to Article 145 of the Civil Code of the Republic of Kazakhstan, taking into consideration the requirements of Paragraph 8 of Article 15 of the Civil Code of the Republic of Kazakhstan, for the popularization of "Courage to be the First" CF's sports events, as well as the Organizer's activities, I give my consent to:
- the video and photo shooting of my image and my child's image (photo and/or video), of the process of my participation and my child's participation in the Competition to be made by the Organizer and/or third parties acting on behalf and/or to the benefit of the Organizer;
  - I grant the Organizer the right to use my name and my child's name, as well as the image of my child and myself obtained during the Competition. I also grant the right to publish, reproduce, distribute, and use my image and my child's image and/or any other audio, video, or photographic materials obtained in the course of the Competition by any means and through any media, without limitations in time or territory. This includes placement on the Internet, on the Organizer's official platforms, publication in mass media, as well as use for advertising, informational, social, and other purposes aimed at promoting sports and charitable initiatives.

9) I hereby grant the Organizer my prior and unconditional consent and authorization to act at their discretion **on my behalf and on behalf of my child** in order to protect our rights and legitimate interests in the event of unlawful use of our images by third parties, including:

- sending claims and demands to cease the violations;
- filing actions with courts and other authorized bodies;
- requesting the removal of illegal content and the blocking of unlawfully posted images and materials (publications);
- claiming compensation, including compensation for moral (emotional) damages.

The Organizer is not obliged to take these measures in every case and independently determines the necessity and the scope of their application. The Participant who has granted this consent on their own behalf and on behalf of their child shall not have the right to bring claims against the Organizer if the Organizer decides not to take such measures.

10) when signing this Acknowledgement, I confirm that I am not under the influence of drugs, intoxicants or alcohol, my health state allows me to exercise and protect my rights and execute duties, I do not suffer from any diseases that can hinder my understanding of the document I signed, and also acknowledge that I am not under the influence of deceit, fraud, violence, threat, bad faith collusion or concurrence of difficult circumstances.

11) I confirm, declare, and guarantee that this Acknowledgement is written by me, and in the case that the Acknowledgement is not signed by me in person, the Organizer shall not be held liable hereunder;

12) I confirm, declare, and guarantee that all risks associated with possible errors or inaccurate data provided shall rest entirely upon me as the participant. I therefore assume full responsibility for all such risks as a legally capable individual;

13) I acknowledge, confirm and guarantee that signing of the Acknowledgement by third parties, as well as provision of inaccurate personal data may serve as grounds for refusal of admission to the Competition without refund of the registration fee.

The text of this document has been read by me on my own. Its content complies with my true goals and intentions. The meaning and legal consequences of the document are clear to me.
